## Call for Expressions of Interest

### First Nations Community Liaison - Deloitte Indigenous Support Services

November 25, 2024

#### Overview

The BC Assembly of First Nations seeks expressions of interest from qualified individuals to serve as First Nations Community Liaisons supporting the Implementation of the First Nations Child and Family Services, Jordan's Principle, and Trout Class Settlement Agreement. This \$23.34 billion settlement aims to compensate those harmed by discriminatory underfunding of First Nations Child and Family Services programs and the federal government's narrow interpretation of Jordan's Principle.

#### Position Mandate

The First Nations Community Liaison will:

- Act as the main point of contact to ensure communities are informed about the Settlement Agreement and Claims Process
- Work directly with First Nations and First Nation organizations in the implementation of the compensation
- Support claimants through the various settlement phases, including Removed Child Class, Jordan's Principle Class, and associated Family Classes
- Facilitate political, technical and community meetings and briefings on settlement updates
- Collaborate with Claims Helpers and Service Coordinators to ensure comprehensive support for claimants
- Remain up to date and informed on Settlement Agreement administration and implementation
- Help coordinate trauma-informed, culturally sensitive support services
- One year mandate with a possibility of extension

#### Position Requirements

Candidates must

- Have 5+ years of experience working with BC First Nations communities
- Demonstrate understanding of Indigenous knowledge systems, beliefs, and practices
- Possess excellent written and verbal communication skills
- Show political acuity and understanding of Canada-First Nations relations
- Have experience working with First Nations leadership
- Demonstrate strong organizational and time management skills



- Be proficient with Microsoft Office applications
- Be willing to travel up to 60% within Canada
- Have ability to manage trauma-informed discussions

**Preferred Qualifications**

- Project management experience
- Is a citizen of a BC First Nation
- Experience with First Nations class action lawsuits

**Time Commitment**

- One year, with possibility of extension
